GLOBAL MIGRATION POLICY WORKSHOPS: A TRILOGY

UNDERSTANDING REALITIES, DEFENDING MIGRANTS, PROMOTING GOVERNANCE BY AND FOR ALL

Three complementary "round-table" workshop sessions following the main themes of WSFM 2012 intended to tell the whole story, build the narrative and trace the roadmap on global migration, human rights, social participation and governance of migration today and tomorrow:

- 1) Summarizing knowledge and analysis on migration today: its relationship to economies, societies and the world of work; conditions and treatment of migrants; social change and cohesion, and who are the stakeholders
- 2) Addressing human rights in migration, international conventions and the rule of law; using mechanisms to defend migrants; and building action alliances among key stakeholders
- 3) Assessing the existing system of migration governance; challenging the global deregulatory assault on migrants and on international standards and institutions; **imaging the future of migration and its governance**

The Narrative

Economic, demographic and technological trends are increasing dependency of countries worldwide on foreign skills and labour, while absence of decent work and repressive conditions displace millions, making human mobility a predominant feature of contemporary globalization. The very viability of labour forces and economies in the South as well as the North depends on labour and skills mobility, and will more so in coming years. Yet widespread abuse and exploitation of migrants/foreigners undermines decent work and social welfare in many situations. Discrimination and xenophobia are on the rise in every region. News media, public discourse and political campaigns are dominated by imagery of migrants and migration threatening security, society and the very identity of nations.

The rule of law and legal mechanisms remain the essence of guaranteeing protection for migrants as well as democratic governance. They are also vital means for organizing migrants and winning hearts and minds. However, the standards, institutions and mechanisms to protect migrants and regulate migration that were carefully constructed over the last century are today deliberately abandoned.

The disabling of existing protections and institutions takes place with little resistance and no alternative. The coherency of intergovernmental organizing around a deregulatory agenda is unmet by social partner, civil society and migrant organizing to defend and extend their rights and gains and to promote a future built on human rights, democratic participation and attainment of welfare for all. A shared new vision is needed, as is an adequate grasp and knowledge of current realities. Viable, democratic and rights-based governance requires mobilizing stakeholders, building alliances and conducting effective advocacy. These in turn depend on having a clear roadmap for cooperation and common action.
