#### What is GMPA?

The *raison d'être* for Global Migration Policy Associates is to support, encourage and generate knowledge and analysis for a broad-based international defence of the rights-based approach. This during an epoch in which an instrumental cost-benefit logic of social analysis, of "human resource management" and of migration management has become predominant, including among those who consider themselves humanitarian in their worldview.

GMPA comprises a unique cooperative network among a score of preeminent migration experts across all regions of the world. Members reflect a number of academic and practical disciplines addressing the multiple aspects and impacts of migration. Its members possess knowledge, experience and commitment to human rights necessary to challenge the rationale that exclusion is the collateral cost for national and international development.

GMPA seeks to "think outside the box", reminding colleagues at every level of government and civil society that migration and migrants don't have to be *managed* in a relentlessly exploitative way.

In order to 'make a difference' in this context, GMPA is focused on defining a strategic agenda, articulating an analysis and knowledge base independent of the dominant framework, and supporting partner mobilization around common, strategic activities and actions.

### **GMPA's comparative advantage**

GMPA represents and gives life to a rights-based agenda rooted in advocacy, practice and the experiences of migrants worldwide. We give emphasis to migrants as human beings first and foremost, addressing discrimination and equality of treatment for all migrants and immigrants. We offer alternatives to emphasis on migrants as "agents of development" who are praised for their utilitarian value but encouraged to trade away universal rights in exchange for presumed development gains. We uphold human rights, democratic approaches and social justice as defining principles for migration whether temporary or permanent, and promote leadership and action by government, civil society and migrant communities.

An emerging collective analysis built on worldwide knowledge and experience that Associates bring from all regions of the world, from multiple disciplines and from diverse academic, social, professional and practical experiences ranging from 'grass roots' to world-class universities to international organizations.
- **2.** Capability to do research, provide advisory services, teach courses, co-organize events, etc. from global, rights-based, multi-disciplinary approaches.
- **3.** Ability to reach **a broad global constituency**: with 4,000 contacts in governments, international organizations, social partners, civil society, academia and migrant communities worldwide.

#### What GMPA did in 2014

2014 was the third year of operations for Global Migration Policy Associates (GMPA). GMPA activity built on considerable work in 2012 and 2013 combining research, advisory services and conference activities with development of the GMPA secretariat, website and communications.

GMPA organized significant workshops at three major international conferences in 2014, notably the *Rhodes Forum 'Dialogue of Civilizations'* in September, the *ECE Regional Beijing* + 20 *Review NGO Forum* in Geneva, and the *International Metropolis conference* in Milan in November.

Several GMPA Associates were involved in conducting major research projects, regional migration programme development, regional training seminars as well as co-authoring and editing a major Global Migration Group book on youth and migration. GMPA Associates were invited in their member capacity to present keynote speeches at several regional conferences on migration related topics.

# «Round Table» on Human Rights and Migrant Women

'Veterans' tell us this was the largest event on migrant women held at the UN in Geneva in the last 26 years, likely the largest ever, with a total of 100 participants!

The session program and content constituted a comprehensive values- and evidence- based review of conditions, challenges and issues facing migrant women across the 56 country ECE 'region.' The panel speakers represented a broad range of experience and perspective with backgrounds in Africa, Asia and the Americas as well as Europe and, in particular, experience in organizing with migrant women.

This session provided an understanding of the condition of migrant women in the legal and social context of the ECE region while also demanding recognition of migrant women as central to the conversation about women's rights. Migrant and displaced women have emerged as a population group of critical concern in recent years and will likely be more so in the future. Women and girls make up 51% of total migration in the ECE region with higher percentages in some countries. All 12 areas of critical concern in the Beijing Platform for Action apply to migrant and displaced women, although severe gaps in implementation remain, particularly for migrant women in irregular situations.

Speakers and participants raised a series of concerns relating to the welfare of migrant women, refugees, asylum seekers, minorities, victims of trafficking, and displaced women. Key areas of concern range from equality and participation in economic and social life to discrimination at all stages of migration. Issues of continuing concern include integration into host cultures and labour markets, access to social protection and healthcare, and an increasing debate about government policy on sex work, especially as it pertains to trafficking of women and girls. Discussion also included reference to legal empowerment and rights literacy of migrant women, access to education and training, and self-organization of migrant women for the purpose of advocacy and collective bargaining efforts.

The session attracted many activists involved with migrant women's issues as well as other women and men activists, academics, international organization officials concerned with migrant women and their issues. Panelist and participant contributions identified a set of concise, clear and comprehensive recommendations that were taken verbatim into the NGO-CSW Forum report.

First and foremost, that we must reframe the discourse around migrant women. Human rights are women's rights and women's rights are inherently migrant women's rights. Migrant women face a battle on two fronts: equality with men and equality with native born women.

We do migrant women a great injustice when we reduce them to their legal status, their victimhood, or their contribution to economic development. We should celebrate the knowledge, expertise and experience migrant women bring to all Member States. In order to provide a context that allows equal access to the full experience of life in the ECE region, Member States have a responsibility to formulate gender -sensitive, rights-based policy on the basis of equality and non-discrimination.

International law provides the region with international instruments that protect the rights of migrant women. It is not a lack of rules the region suffers, but lack of implementation due to political will.

Human rights are women's rights which are inherently migrant women's rights. States should ratify key international conventions on migration, develop domestic law and policy that reflect the rights based framework upon which these conventions and standards are built, and ensure that mechanism are in place to uphold and enforce such standards.

The overall NGO Forum Summary Report and Recommendations were presented to the UN ECE intergovernmental conference on 6-7 November. The report from the ECE intergovernmental meeting contained a number of references and recommendations regarding migrant women: This NGO session and its recommendations contributed to obtaining those references in the draft ECE conclusions.

Migration is the zone of contention over whether development in MENA countries will continue to rely on abusive exploitation of foreign workers or whether real changes in policy and practice evolve. The *migration workshop* at the Rhodes Forum addressed human mobility as a major global phenomena and a significant vector of dialogue among peoples, nations and civilizations worldwide. Nine experts from diverse realities of Canada, India, Moldova, Portugal, the Russian Federation and the USA presented data, analysis and practical examples on contemporary migration challenges and governance responses. The animated exchange focused on three themes: mobility of labor and skills to maintain viable economies, lessons learned on integration of migrants for social cohesion, and effective responses to the mass refugee influx from the Ukraine into Russia.

The dialogue highlighted that migration today is mainly international labour and skills mobility which is increasingly necessary to maintain productive work forces and viable economies in industrialized countries due to evolution of technology, changes in the organization of work, and demographic decline of work forces in many countries. Reports on evolution of policy in the United States, recent legislative developments in the Russian Federation, and experiences from Bangladesh, India and Nepal helped identify global policy challenges and viable response measures.

Particular attention was focused on governance measures to protect and assist the estimated influx of 800,000 Ukranians into Russia since June of this year. Discussants identified options for providing legal status for Ukranians in refugee-like situations. Others enumerated the policy agenda of measures to facilitate integration of migrants based on successful experiences in Europe and USA.

The workshop concluded that the dialogue on migration and its effective governance in context of intensified international and intercultural tensions is an ongoing work in progress and that it will remain an integral component on the agenda of dialogue of civilizations-- at local and national levels as well as globally.

The workshop was co-moderated by **Lidia Grafova**, President, International Public Association "Forum of Migration Organizations (Russian Federation) and **Patrick Taran**, President, GMPA.

# **GMPA ACTIVITIES 2014**

### I. Research Activities

# 1) Comprehensive normative review of Nigeria national legislation and policy on migration

One of two major GMPA conducted research project of 2014 was the year-long **comprehensive review of Nigeria national legislation and policy regarding domestication of relevant international conventions** on migration governance and the five **ECOWAS Protocols** relating to free movement, rights of residence and establishment and free movement of services/service providers. The research was conducted under IOM auspices with ILO cooperation supported by an EU cooperation project grant. Patrick Taran and GMPA Research Associate Katherine Youtz conducted the research.

The instruments concerned were the International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families (ratified by Nigeria), ILO C-97 On Migration for Employment, ILO C-143 on Migrant Workers, ILO C-181 on Private Employment Agencies, ILO C-189 Concerning Decent Work for Domestic Workers, as well as the ECOWAS Protocols on Free Movement of Persons, Residence and Establishment.


The pioneering research effort involved obtaining texts and interpretations of more than 50 different congressional acts and laws across most categories of law as well as national policy documents; reading some 1,100 pages of Nigeria national legislation as well as the Constitution; creating an analytical matrix to comparatively examine legislation across each of the more than 170 articles in the 5 international normative instruments as well as the 60 or so provisions in the five ECOWAS protocols; conducting stakeholder input and review discussions with experts from some 20 different government agencies, social partner organisations and civil society actors; and engaging in a final validation consultation with national stakeholders prior to publication and dissemination of the reports. The four published reports are listed below under publications.

The research outcome contributed to: improved national legislation in conformity with both ratified and not yet ratified international conventions; to strengthening Nigeria implementation of the ECOWAS protocols; to formulating proposals for ratification of ILO C-143 and C189; and to advancing Cabinet level consideration of the then-draft national Nigeria labour migration policy (adopted by the Federal Executive Council in 2017).

# 2) Drafting the JLMP for Integration and Development in Africa

The other major GMPA project in 2014 (continuing from 2013) was preparing the terms of reference, background documents, initial program activity proposal and a detailed budget for a 4 year €26 million initial phase of the *AU-ILO-IOM-ECA Joint Labour Migration Programme for Development and Integration in Africa (JLMP)*. The work was conducted under joint ILO-AU auspices and involved extensive inputs, consultations and validation by tripartite constituents and 7 regional economic communities across Africa. Broad stakeholder consultations took place over a two year period at an Extraordinary Session of the AU Labour and Social Affairs Commission meeting in Windhoek, Namibia and at a regional conference on migration in Kigale, Rwanda as well as at the African Union center in Addis Ababa.

The AU-ILO-IOM-ECA Joint Programme on Labour Migration Governance for Development and Integration (the Joint Labour Migration Programme or JLMP) in Africa was formally adopted in January 2015 by African Heads of State and Government as a comprehensive programme on labour migration governance for the region. Its strategy focuses on intra-African labour migration and supports achievement of the First 2023 Ten Year Plan of the AU's Agenda 2063 and of the UN Sustainable Development Goals (SDGs). # VIII. Organizational Challenges Ahead

GMPA experience shows the limitations of building a programme and organization on volunteer-based staffing coupled with minimal engagement of some members; most of the substantive organizational work is deferred to one core Associate. Enthusiastic and capable interns have provided staff support since 2013, but, no matter how qualified and professional they may be, their work as staff is strictly short-term. Generating greater organizational involvement by other Associates is essential for GMPA to move forward.

Much of the research and training work of member Associates *de facto* associated with GMPA is invited and contracted to individuals rather than formally to GMPA, as is most advisory and consulting work offered by international institutions, governments and other entities. Stringent institutional requirements for contracting organizations as service providers generally mean preference for contracting with individual experts as consultants. De-coupling individually contracted activity of Associates conducted in name of GMPA, despite stated organizational linkage, subjects it to characterization as «doing very little».

GMPA has built an extensively consulted website providing a large 'data base' of research, publications and policy papers on a broad range of migration related topics. Website hosting data has shown that the website consistently gets over ten thousand hits per month, and downloads of documents surpass one thousand per month, a substantial count for a never-promoted website. However, updating the website and continuing to post new documents requires significant time and effort. While the secretariat was able to assign capable interns over part of year to regularly post and update, no one has assured this function on a permanent basis, leaving the site outdated and therefore less relevant over periods of time.

Significant demand for research, policy advice and consultation activities directed at and substantially influencing policy and practice of governments, international organizations and regional inter-governmental bodies is manifestly evident. However, GMPA has not had capacity to do 'resource mobilization' with its minimal staff time over-committed to current projects and activity. Nor have any other Associates taken initiative to identify, followup on and prepare applications for potential funded activity.

In only three years, GMPA has established itself organizationally as an international independent expert network with a formal non-governmental identify; it has produced significant products and results, it has organized successful events as a part of global conferences and processes and it achieved wide visibility, name recognition and standing. This was accomplished in a period when all but two other international migrants rights-specific civil society organizations disappeared –in part due to resource starvation. Nonetheless, GMPA credibility and viability is called into question by some actors because it has not received significant external organizational funding. However, the absence of resource support occurs as funding and support to many human rights organizations and policy activist civil society organizations is declining. Furthermore, foundations and governments that have provided support to migration activity by civil society and academia have made explicit indications that they are not interested in funding activity – or organizations – supporting/advocating in promotion of normative instruments on migrants rights.
