About GMPA

Global Migration Policy Associates is a unique network among migration experts in all regions of the world. Its Associates reflect diverse academic and practical disciplines addressing multiple aspects and impacts of migration. The organisation seeks to support, encourage and generate knowledge and analysis for a broad-based international defence of the rights-based approach. It challenges and articulates alternatives to the instrumental cost-benefit logic of 'migration management' predominant today. In order to 'make a difference', GMPA articulates knowledge and analysis independent of the dominant framework while supporting member and partner mobilization and activities.

GMPA conducts its activity with financial and other resources from modest member dues and project funding for research, advisory, and training activities. GMPA has never received external grant or other funding to sustain core operations and administration, instead 'supporting itself' by *pro-bono* voluntary staff work by member Associates and *cooperants*. It thus retains an ability to function independently of agendas, grant conditionalities, and funding cycles of other international or national institutions, philanthropic foundations, or governments.

GMPA's comparative advantage

We represent and give life to a rights-based agenda rooted in advocacy, practice and the experience of migration worldwide. We give emphasis to migrants as human beings first and foremost, addressing discrimination and equality of treatment for all migrants and immigrants. We offer alternatives to emphasis on migrants as "agents of development" who are praised for their utilitarian value but encouraged to trade away universal rights in exchange for presumed development gains. We uphold human rights, democratic approaches and social justice as defining principles for migration whether temporary or permanent, and we promote leadership and action by government at all levels, social partners, civil society and migrant communities.


GMPA concentrated its work in research, policy development and training work described on following pages. Salient accomplishments included: preparation, publication and board approval of a comprehensive evaluation of ILO International Training Center activities on migration for employment/labour migration; providing professional training for Ethiopian government and social partner officials, for Tunisian trade union social workers and organisers, for tripartite officials of seven IGAD countries, and labour attachés from numerous countries; initiating an ambitious effort supporting the IGAD - Inter-Governmental Authority on Development to develop a common approach on Bilateral Labour Agreements – BLAs; contributing to and co-editing 11 national reports on European countries and co-authoring an EU-wide report on migration and development. Also, the GMPA President presented a global overview plenary address at an International Conference of migration museum curators 'Experiencing the Museum: People with Migrant Backgrounds' in Moscow in December.

I. Main GMPA Research, policy advisory services, and evaluation work in 2019:

Four main research activities occupied the core GMPA team over the course of the year:

1. In 2019, a GMPA team (Olga Kadysheva, Patrick Taran, Wickramasekara) supported finalisation publication of 11 Caritas national studies in EU countries (Austria, Belgium, Bulgaria, Czech Republic, Germany, Italy, Netherlands, Portugal, Slovakia, Slovenia, and Sweden) on migration and development explicitly tying to the Sustainable Development Agenda (published and launched in May 2019). GMPA cooperated in the development of structure/outline, identifying relevant literature and data sources, revision, editions and comments on 3 drafts of each national report over 2018. In early 2019, the GMPA colleagues final edited revised drafts for publication of all 11 national reports. (See list of reports on pp.10-11)

From early 2019 to mid-year, the GMPA core team (Olga Kadysheva, Patrick Taran, Piyasiri Wickramasekara with support by Addie Cusick, Katya Garcia-Israel, Jaycee Greeley and Tara Thomas) researched and drafted *Common Home: Migration and Development in Europe and beyond* report (finalised and published in Fall 2019). The work was under contract with Caritas Europa, as part of the *MIND – Migration. Interconnectedness. Development* project, financed by the European Commission (DG DEVCO).



- 2. **Evaluation of the ITC ILO labour migration training activities.** Patrick Taran was Team Leader with support by Olga Kadysheva for a thorough, first time evaluation of the labour migration activities (over a two year period) of the International Training Center of the ILO. The evaluation entailed work over four months in 2019 adapting OECD, ILO and GMPA evaluation methodology and criteria to this specific programme and content and included interviews/assessment meetings with ITC-ILO executives and trade unionists, analysis of findings, and preparation and revisions of report and recommendations. - 3. A GMPA team (Patrick Taran and Olga Kadysheva with assistance by GMPA Research Associates Katya Garcia-Israel and Jaycee Greeley) continued research and revision of the draft comprehensive **City Practitioners Handbook** on *Welcoming Migrants and Refugees; towards inclusive and sustainable cities,* to be published by/with UNESCO in collaboration with ECCAR European Coalition of Cities Against Racism, and GMPA, in 2021/22.
- 4. Formulation and initiation of large scale project for **research and evaluation of Bilateral Labour Agreements (BLAs)** and **development of Guidelines on a common rights-based approach for the IGAD**—Intergovernmental Authority on Development (among East Africa-Horn of Africa countries Djibouti, Ethiopia, Kenya, Somalia, South Sudan, Sudan and Uganda). Core team was Patrick Taran and GMPA Vice-President Piyasiri Wickramasekara, supported by Associate Olga Kadysheva with research assistance by Maribini Muswede. The project was proposed by/to ILO in August and initiated in November 2019 and carried through to November 2020. (Details in 2020 report).

II. GMPA-conducted trainings and participation in conferences in 2019:

II. A. Knowledge-sharing and training activities with International Training Center of the ILO (ITC ILO)

- **1.** Patrick Taran, GMPA President was lead trainer with Vincent Williams of South Africa at the ILO-ITC training course *Enhancing the protection of low-skilled migrant workers* (26-29 March 2019, Turin). Training participants included senior government officials from the Ministry of Labour and Social Affairs, the Attorney General's office, the Ministry of Foreign Affairs, Consular Officers from Ethiopian missions in several Middle East and GCC countries, senior officials of the Ethiopia Employers Federation and from the national Federation of Trade Unions. - **2. Piyasiri Wickramasekara**, GMPA Vice-President was lead trainer at the ILO-ITC training course *Negotiating Bilateral Labour Agreements*, **Turin**, **Italy** (17-21 June 2019).



This was the second training course on bilateral labour agreements launched by ITC ILO. The participants representing government officials and social partners were drawn mostly from African countries: Cameroon, Ivory Coast, Morocco, Tunisia and the Secretariat of the Intergovernmental Authority on Development of East Africa. In addition, there were two participants from Bulgaria. The course was bilingual – English and French. It covered major issues relating to the development and implementation and follow up of bilateral labour agreements and related negotiation processes. Dr. Piyasiri Wickramasekara was the lead trainer on technical issues of BLAs.

3. Piyasiri Wickramasekara, GMPA Vice-President was lead trainer at the ILO-ITC training course *Strengthening labour attaché services for better governance and protection of migrant workers*, Turin, Italy, 2-6 September 2019. This was the second edition of the training course delivered to government officials serving in Bangladesh missions in the Middle East and Asia and the ministry responsible for migration in Bangladesh (Ministry of Expatriate Welfare and Overseas Employment). 20 officials participated in the event. The agenda covered issues relating to roles of labour attaches, relevant international instruments, protection issues of migrant workers, conflict management and dispute resolution, labour inspection systems, bilateral labour agreements and promotion of labour market opportunities and reporting procedures. The GMPA resource person contributed to the development of the course agenda, prepared and delivered presentations during five sessions from 2-6 September 2019, supervised group activities, and acted as a resource person throughout the above course.

The Refugee and Migratory Movements Research Unit (Dhaka, Bangladesh) organized the two-day Conference on 'Transforming Challenges of Migration into Opportunity: Call for declaration of Migration decade in Bangladesh' jointly with with British Council's Prokas Programme and UKAID. article, "Experts demand declaring 2021-30 as migration https://www.newagebd.net/article/80009/onelink.to/nagadapp). The Conference addressed issues of protection, cost of migration, climate change and migration, remittances and reintegration of returning migrants. Panels in each session identified the challenges, and actions to be taken during the Migration Decade followed by a floor discussion. The GMPA Expert, Dr. Piyasiri Wickramasekara contributed to revision of the concept note and the agenda of the Conference. He also acted as the moderator of Session 1 on the Protection of Migrant Workers. He also participated in the high level panel at the end of the conference and made some remarks on suggestions made by various stakerholders for the proposed Migration Decade.

9. Piyasiri Wickramasekara of GMPA was the lead resource person for the **ASEAN Workshop on Reintegration Programmes for Returning Migrant Workers** responsible for developing a background report on Effective Return and Reintegration of Migrant Workers in ASEAN for the ILO and the Government of Indonesia. The report was validated at the ASEAN Workshop on **Reintegration Programmes for Returning Migrant Workers**, organized by the Ministry of Manpower, Government of Indonesia, and the ILO TRIANGLE in ASEAN programme, 27–28 August 2019, Yogyakarta. The tripartite members of the ASEAN Committee on Migrant Workers (ACMW) offered comments and suggestions for improvement of the background report. Wickramasekara presented the elements of the revised draft at the final session of the workshop.



2019 Featured Activities

Evaluation of the ITC-ILO labour migration training activities

Patrick Taran was Team Leader with support by Olga Kadysheva for a thorough first time evaluation of the migration for employment/labour migration activities of the International Training Center of the ILO. The evaluation period covered a two year span of activities 2016-2018, 30 ITC trainings, academies, and field trainings in several regions. The evaluation was awarded to GMPA with Patrick Taran as expert evaluator, contracted with the ITC Evaluation unit following an open call for proposals.



In view of the specificity of the field of migration for employment/labour migration and the specific context of ITC-ILO training approaches and methdologies, the team elaborated a hybrid evaluation approach and methodology assessment criteria, indicators and measures adapted to these specifics combining OECD DAC, ILO evaluation, and GMPA evaluator knowledge, approaches, methodology, criteria and experience. The latter included prior GMPA-conducted Midterm Evaluation of the EU-Africa MMD -migration and mobility for development cooperation partnership and the Evaluation finale programme MEET Africa-Mobilisation Européenne pour l'Entrepreneuriat en Afrique commissioned by Expertise France.

The exercise thoroughly evaluated the ITC-ILO migration activities according to six overall combinant criteria with indicators and measurement adapted from OECD-DAC and ILO evaluation approaches: 1) Relevance; 2) Validity and Coherence of Design; 3) Effectiveness (overall); 4) Impact and Susatainability; 5) Efficiency; 6) Effectiveness of Management, Visibility and Monitoring arrangements. The evaluation also addressed cross-cutting policy drivers of the Centre: 1) innovation and learning; 2) gender equality and diversity; and 3) tripartism, social dialogue and international labour standards.

The evaluation entailed nearly full-time work over four months in 2019. The activity included:

- study and analysis of extensive documentation on all the training activities conducted over the period, both in Turin and in locations in Africa, the Middle East and Latin America (programme documents, activity descriptions, agendas, participant lists, presentation materials, participant evaluations, etc);
- co-designing with the ITC evaluation office an online survey sent to the 500 participants in the trainings over the previous 2 years (108 responses –21%-- a good response rate by industry standards);
- 32 in-depth interviews (most 60-90 minutes each): in-person assessment meetings with ILO-ITC executives in Turin and ILO and IOM officials in Geneva and virtual focus group and individual meetings with concerned government, employer organisation and trade union officials worldwide.
- two in-depth case study examinations of ITC training and learning activities in participants' organizations and contexts: *trade unions* and *Ethiopia*;
- careful evaluative analysis of data and findings using our hybrid OECD-DAC and ILO criteria, indicators and assessment approach; and
- preparation and revisions of the report and recommendations.

2019 GMPA feature activity

Participation in the international migration museums conference Experiencing the Museum: People with Migrant Backgrounds, Moscow

The conference *Experiencing the Museum: People with Migrant Backgrounds* took place over three days 5-7 December, 2019 at the **Garage Museum of Contemporary Art**, Moscow's premier modern art museum, with participation by migration museum curators and other professionals in spheres of museums, migration, and culture from Australia, Belgium, Denmark, France, Germany, the Netherlands, Russia, and the UK among other countries, also the European Union and UNHCR-United Nations High Commissioner for Refugees office. Participants discussed issues and trends in the fields of international migration and forced migration; specifics of interaction between cultural institutions and people with migrant experiences; and education and work with young people including migrant and refugee youth.

"Museums have immense potential and key responsibilities to serve as educational, mediating and policy influencing agencies. Museums provide the space and place to document and demonstrate the dignity and humanity of all persons concerned, as well as their cultural heritage. They can show —and explain—the contributions of migrants and migration to the development of human culture, its many socio-cultural, ethnic, religious and linguistic identities, and the vast richness of cultural expression across that diversity. They can serve as places to enhance the understanding of host populations about their own histories of migration. Museums can offer migrants and immigrants access to the host society identity, history and contemporary life as well as providing a meeting and mediating point between both.

Museums also have opportunities and roles to play in safeguarding cultural heritage and reclaiming peoples' histories, individually and collectively. An important role adopted by a number of museums is providing space and place for people expelled and exiled from their native lands to restore and maintain their cultural heritage. This is an especially important responsibility as many indigenous and minority cultures and languages are threatened with disappearance, indeed extinction, around the world. Safeguarding heritage is recognized as so important as to merit an international Convention, the UNESCO Convention for the Safeguarding of the Intangible Cultural Heritage (2003).

Museums have an especially important role to play in changing the narrative towards a respectful, inclusive understanding of migrants and migration, away from the dominant criminalising and dismissive imagery reinforced by official discourse and policy as well as media coverage and imagery. More than academics or a seriously constrained civil society, museums and other cultural institutions have the place and space to do the research, bring together artists, art and thinkers and collect and create the cultural manifestations to establish a fuller historical and contemporary understanding of migratiom and migrants. Cultural institutions have by definition tangible and intangible art and artefacts, the visual images, music, dance, photography, plastic arts, and so on to make real and tell the stories of what human mobility and migration is and means for country and society—and for migrant and refugee peoples and communities".
